“As a professor, I
have the privilege of
preparing law
students to offer legal
assistance to those in
need and instilling in
them an ethic of pro
bono service. It is so
powerful to hear
students describe the
moment they realized
that the three hours
they spent on a
Saturday morning
helped to change
someone's life. Years
later I will get calls
from those same

students about the
pro bono work they
continue to do. It's
inspiring to me.”

“I would tell any
lawyer who has not
done pro bono yet to
just try it once. I
predict that you will be
hooked. It is one of
the most rewarding
experiences to give
someone legal advice
who cannot afford to
hire a lawyer. The
clients are so grateful
for your time. And
doing pro bono has
never been easier.

responsibility to serve

give back. I am very
proud that this
responsibility is
recognized in Rule
6.1 of the Tennessee
Rules of Professional
Conduct, which sets a
goal of 50 hours of
pro bono service a
year for every
practicing attorney.”
