The Stories of Pro Bono in TN

This month's stories are submitted by **Tennessee Supreme Court Justice Holly Kirby**. We are so thankful for the support of the Tennessee Supreme Court and the leadership of Justice Kirby!

"At a Saturday Legal Clinic, I assisted a woman whose elderly mother was being financially exploited by her son, my client's brother. My client had

little education but was passionate about protecting her mother. At my urging, she contacted Adult Protective Services, with little success.

After my client described to me her frustrating conversation with APS, I called them on my client's behalf, and my client's mother was soon safe. **From that experience, I learned how hard it is for those without education or financial resources to get the help they deserve. One call from a lawyer changed two lives forever."**

"Representing a distressed child in juvenile court, enabling a young mother to divorce her abusive husband, representing a family about to be evicted from their home - this kind of work is done daily by Tennessee attorneys who volunteer their expertise to give a voice to those who otherwise would be on their own. Pro bono work may not be glamorous, but it is rewarding. Each hour given in service is another child rescued, another domestic violence victim protected, another family saved from foreclosure. Try it!"
