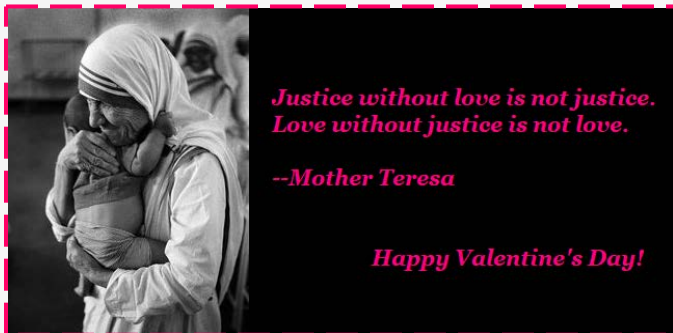

**Dear Tennessee Faith & Justice Alliance members,**

What if when we thought about Valentine’s Day, we thought about pro bono? Indeed, love and justice go hand in hand, even better than chocolate and flowers! What would happen if we all committed to renewing our passion for pro bono and gave love, real love, in the form of justice to our communities this February?

**This Valentine’s Day we challenge Tennessee attorneys and faith leaders to *fall in love with pro bono... perhaps all over again.***

Fundamental to the idea of falling in love with pro bono is that by fostering access to justice to those in our communities, we both give and receive love. *But what is love?* Rabbi David Wolpe writes in [TIME Magazine](#) that love is “when one person believes in another person and shows it.” Rabbi Wolpe goes on to explain that love “is a feeling that expresses itself in action. What we really feel is reflected in what we do.” By choosing to offer services pro bono publico, attorneys show their belief in fellow humans or, stated differently, *love their fellow human*. Therefore, falling back in love with pro bono at Valentine’s Day is easy because pro bono is a form of love.

Still not quite persuaded that Valentine’s Day and pro bono are the ultimate romance? Buck Lewis reminds us that one of the most fundamental reasons to do pro bono is based in a simple love for one’s fellow man. Buck explains,

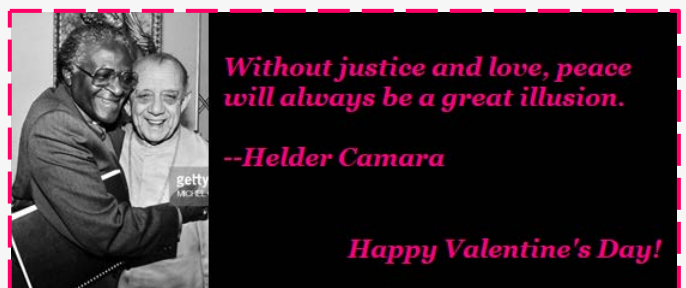
“Who are these people with legal problems who cannot afford a lawyer? They are our brothers and sisters. Like my Grandfather, they paint our houses, fix our roofs, and clean our gutters. They work in the hotels where we stay. They serve us our food at our bar luncheons. And some of them struggle to make ends meet between their first and second or second and third tours of duty. Most of them are smart, not dull. Most of them are hardworking, not lazy. It’s just that when privilege was given out, they were sitting at the back of the room...”

For people of faith, this love may take on even greater meaning as love and justice intersect and intertwine with many forms of religious practice and tradition. One such example is expressed by John Dear SJ, who writes in his introduction to Henri J.M. Nouwen’s [The Road to Peace: Writings on Peace and Justice](#) that,

“I agreed that we are all the beloved of God, but in a world of injustice, we are required to work for justice... As the beloved of God, we must dedicate ourselves to relieving the suffering of the poor... The life of the beloved children of God, I pointed out, promotes life for all, especially those suffering the brunt of death—the third world poor, the hungry, the homeless, the imprisoned, those on death row, the unborn, children, and the victims of war.”
